 Plantation or Mannor of Wingfield wth the appurtenances To hold to him the said Michael
 Lambert his Executors Admors or Assignes from the five and Twentieth day of March
 next ensuing the date hereof for and during the Term of fifteen years And Whereas
 the above bound Michajah Perry and Richard Merriwether did agree with the said
 Christopher Joafferson before his executing the said lease to become Bound with the said
 Michael Lambert for the payment of the Rent and for maintenance of the Covenants & Agreem^{ts}
 therein mentiond If therefore the above bound Michael Lambert Michajah Perry and
 Richard Merriwether or any of them their or any of their heirs Executors or Admors
 or any of them doe and shall well and truly pay or cause to be paid unto the above
 named Christopher Joafferson his Executors Admors or Assignes the said Sum of four
 hundred pounds of good and Lawfull money of Great Britain in the Common Dining Hall
 of the Middle Temple London on or before the five and Twentieth day of March
 next ensuing the day of the date of these presents And if the above bound Michael
 Lambert his heirs Executors Admors and Assignes and every of them shall and doe
 for his and their parts in all things well and truly perform full fill Accomplish pay &
 keep all and singular the Covenants Grants Articles payments Conditions and
 Agreem^{ts} w^{ch} dooever w^{ch} on his and their parts and behalves are or ought to be
 observed perform full fill d^d Accomplish paid and kept comprized & mentiond
 in the said recited Indenture of lease and that in and by all things according to the
 contents purposes true intent and meaning of the same Indentures without fraud or
 covin Then this present Obligation to be void of no effect or else to be & remain in full
 force and virtue
